



## **Germany's Kreissparkasse Bank Selects NCR's Deposit and Recycling Technology; NCR Personas M Series' Modular Design Provides the Flexibility Needed to Successfully Introduce New Functionality**

The NCR Personas M Series 74 and 76 machines give Kreissparkasse Bank the opportunity to quickly and easily introduce cash deposit and recycling, with a simple upgrade to their cash-dispensing ATMs. Recycling is popular outside of the United States, allowing cash that is deposited in the ATM to be immediately dispensed to customers making withdrawals.

As part of a three-year agreement, NCR will also provide maintenance and services through its Worldwide Customer Services Division for all ATMs used by Kreissparkasse Bank. This services contract covers ATMs from multiple vendors and NCR Personas Print account statement printers that have been used by the bank for several years.

Kreissparkasse Bank decided to introduce the additional deposit and recycling functionality on NCR Personas M Series ATMs following the successful introduction of several machines used only to dispense cash. The bank found that the intuitive design of the ATM and its large touch screen were very popular with both customers and staff alike.

The widespread acceptance of NCR's Personas M Series convinced the bank that its customers will find the new functions easy to use and will quickly adopt them. The ATM's modular design offers greater deployment flexibility and options for the introduction of the new deposit and recycling functionality in its branches.

"Not all our branches are currently relevant for automated cash depositing, either with or without cash recycling, but this situation may change soon. With the NCR Personas M Series, we are perfectly prepared. If necessary, we just need to replace an internal module to add this functionality," said Jan Wecke from Kreissparkasse Bank, explaining the main reason for deciding in favour of the NCR Personas M Series. "Furthermore, we have received very positive feedback from our customers and staff since the first use of this new generation of self-service solutions, in regard to the new intuitive design and the convenience of the large touch-sensitive screens."
