The data warehouse and master data management system were developed as integrated solutions to ensure one common, accurate set of information for regulatory and management reporting, as well as query capability.

According to Technology Managers Forum, the project was chosen because it is symbolic of a philosophy of best practices providing a model for the industry that can be quantified, adapted, and repeated.
