The EDW will provide BOS with a single view of its business for analysis across departments and systems. It will enable the bank to make better and faster decisions, effectively manage risks and optimize its customer relationship management.

BOS has always been an early adopter of information technology. As early as 2004, BOS began to build its core banking system, "T24," which has been operational since May, 2006. As its business grew, BOS needed to develop analytical applications that allow queries and analysis of historical data from various business information systems. This need led the bank to the decision to build an integrated data warehouse platform to ensure high data quality for smooth business operations and development.

As a leader among more than 100 city commercial banks in China, BOS is a fast-growing bank with outstanding financial performance, holding a strategic position in China's banking industry from IT vendors' perspective. Therefore, the tender for the EDW project attracted intense competition by HP/Neoview, Sun/Greenplum, IBM/DB2, and Teradata. By then, it will be an advanced, flexible and scalable platform that will effectively integrate data from different systems and platforms across the entire bank. It will support and help to improve the bank's information management systems.
