## Tom Thumb and Randalls stores converted from DVDPlay kiosks to BLOCKBUSTER Express

In addition, customers now will be able to return DVDs two hours later at 9 p.m., as well as rent DVDs online at <u>blockbusterexpress.com</u>.

"We are thrilled to bring an even better experience with the newest releases, a greater selection of DVD titles, and later return times through the BLOCKBUSTER Express experience."

Consumers can conveniently return DVDs to any BLOCKBUSTER Express kiosk - not just where they rented the DVD. No membership is required to rent a DVD at a BLOCKBUSTER Express kiosk - customers simply swipe their credit card and are charged \$1 per night until they return the DVD.
