

# NCR Provides XML Support for Teradata(R

DAYTON, Ohio, Sept. 27 /PRNewswire/ -- NCR Corporation (NYSE: NCR) today announced that its industry-leading Teradata database now supports Extensible Markup Language (XML), the Common Warehouse Model (CWM), and the Open Information Model (OIM).

With these new XML capabilities, NCR data warehouse customers will be able to import and export XML documents to and from Teradata. This feature is particularly valuable to companies in industries where XML standards have been developed for the electronic exchange of information. In addition, NCR and Meta Integration have worked together to provide support for industry standard metadata models such as the CWM, OIM, and other vendor specific metadata models.

NCR Teradata customers can download the XML data access middleware online from Meta Integration Technology, Inc. at www.metaintegration.net . Meta Integration sells the NCR Teradata middleware online starting at \$500 per download, the complete set of software middleware components sells for approximately \$5,000.

XML, developed by the W3C, is a pared-down version of the Standard Generalized Markup Language (SGML). XML employs tags to add meaning to the content of electronic messages.

Document Type Definitions (DTDs) defining the meaning of tags specific to industry groups have been developed to facilitate B2B and B2C e-commerce. Examples of industry standard DTDs include HL7 for health care, FpML for finance and Microsoft's BizTalk initiative for business-to-business e-commerce.
