Explanation of Responses:

- These are time-based restricted stock units that were granted due to the overperformance of 66,096 performance-based restricted shares granted February 13, 2006. As a result of the Company's spin-off of the Teradata Data Warehouse Division, those 66,096 performance-based restricted shares were converted into 143,378 performance-based restricted shares, 2/3 of which vested on October 24, 2007. Because the Company's performance as of the spin-off exceeded the performance targets, the Compensation and Human Resource Committee elected to award the reporting person with time-based restricted stock units in the amount reported. The restricted stock units will vest on December 31, 2008, providing the reporting person is still employed by the Company on that date. The remaining 1/3 of the original award was converted into 1-year performance-based restricted stock unit awards that vest December 31, 2008, if applicable performance criteria are met.
- This share total reflects the conversions that took place as a result of the spin-off of the Teradata Data Warehouse Division.
