**Explanation of Responses:**

- These shares were withheld to cover tax withholding obligations resulting from the December 31, 2021 vesting of 6,354 previously reported restricted stock units awarded under the long-term NCR Strategic Transformation Fitness Plan pursuant to the Second Amended and Restated NCR Management Incentive Plan.
- Performance share restricted stock units (RSUs) as to which the performance-related conditions to vesting were satisfied on December 31, 2021. These RSUs vest ratably, with 50% having vested on December 31, 2021 as shown on Table I, and the remaining 50% shown on Table II scheduled to vest on December 31, 2022 subject to certain conditions.
- These shares were withheld to cover tax withholding obligations when 58,928 performance share RSUs vested on December 31, 2021 as reported herein.
